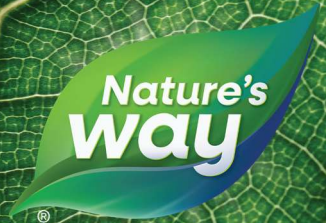

To support memory and concentration, our ginkgo biloba leaves' chemical constituents must be the same in every batch of Ginkgold.* But nature doesn't give us the same rain, sun, and soil content every year. So, we established agrichemical-free ginkgo farms in France, China, and the United States.

This enables us to combine leaves from three climates and adapt their ratios to deliver the same chemical content in every tablet!



EXCELLENCE EVERY STEP OF THE WAY

In-Process Testing	Performs end-to-end testing every few minutes throughout manufacturing.
Analytical Lab	Ensures product is free from harmful levels of contaminants and flawlessly formulated to perform as claimed.
Microbiology Lab	Verifies products are pathogen free and that all materials meet quality standards.
Physical Lab	Tests flavor, appearance, and sensory qualities for the customer experience.
Stability Testing	Proves products will perform effectively through the expiration date.

WHY QUALITY MATTERS

Safety is another important reason to know how and where your supplements are sourced and made. If a manufacturer uses an ingredient that's even minutely different from its chemical composition in the original formula, then they can't guarantee the final product is safe. We go beyond compliance to not only verify our source materials are potent, pure, and safe for you, but also test them throughout the manufacturing process and beyond.
