Rates based on ocean carrier providing chassis at same location of container p/u and return. For any repositions (chassis splits) or lifts an extra charge of \$100.00 applies per instance.

Tri Axle charge \$100 (if needed) for 20' between 17.6MT - 19.6MT

All FCL drayage rates are subject to any layover fees from vendor due to longer haul moves with the new ELD rules in effect.

#### **Detention**

A Per Diem charge applies when the use of container is required beyond the below mentioned free time. Free time day 1 is defined as the day the container leaves the port or rail yard.

Per diem fees accumulate until return of the equipment (Container) to the port terminal or rail yard. DHL Global Forwarding USA provides the following Per Diem Tariff: Free-time – Per Diem - Import / Export- Standard, HC, containers- 4 business days, Refrigerated, Flat-rack & Open top containers- 2 business days.

Amount per day for containers only, Standard, HC & Open Top containers-1-5 calendar days \$150.00 per container per day, thereafter \$175.00 per container per day.

Amount per day for containers only, Refrigerated, Flat-rack & Open Top containers -1-5 calendar days \$425.00 per container per day, thereafter \$450.00 per container per day.
