**Comments:**

This is an FDA Contract Audit GMP/ Limited scope PC inspection under 21 CFR 117 Subparts ABDEF. The inspection focuses on significant observations that may cause serious adverse health consequences or death; and adulteration and misbranding that may occur during the receiving of ingredients. The Good Manufacturing Practices cover cleaning, sanitizing and employee practices; allergen cross-contact and labeling; cooking, formulation using pH, water activity, ingredients, cooling and refrigeration. This inspection was conducted as an audit. Susan Kendrick of ODA was the auditor.

This facility is a manufacturer of gluten free dry pasta. Gluten free elbow pasta was being produced at the time of inspection.

The firm must register as an FDA Food Facility using 21 CFR Part 1.225-.243 unless exempt as a domestic residence or greater than 51% retail gross sales.
